

1.USB"A" connector

Please insert the FINAL USB type "A" connector into the computer or iUSB Power labelled " $\square + \downarrow$ ".

2.USB"B" connector

The FINAL USB type "B" connector labelled 'iFi' please insert into the type "B" port of the DAC or the iPurifier (which is then inserted into the DAC).


3.RF³Silencers

All USB cables due to their inherent nature inevitably pickup AND radiate radio frequencies that negatively impact the sonic performance.

On the Mercury USB cable, there are 3 sets of RF³ Silencers. Two are best located at each respective end.

Note: The custom-designed metal oxide ceramic RF silencers offer different permeabilities. Compared to generic filters this atypical approach is incredibly effective; over the widest frequency range.





to attain the optimal sonic performance for a given situation.

Tip: To start with, set this 3rd RF Silencer to the 'Golden Ratio', with the shorter section closer to the USB 'B' connector (item 3 above).
